

RESOLUTION NO. 16-4
RESOLUTION OF THE GOVERNANCE BOARD OF THE
INTEROPERABILITY NETWORK OF THE SOUTH BAY
JOINT POWERS AUTHORITY
ADMITTING THE
CITY OF REDONDO BEACH, CALIFORNIA,
TO THE AUTHORITY

WHEREAS, the Interoperability Network of the South Bay Joint Powers Authority ("INSB JPA") is engaged in the regional and cooperative planning and coordination of governmental services to establish and sustain a wide-area interoperable land mobile radio ("LMR") network; and

WHEREAS, the INSB JPA seeks to enhance the current public safety and general government LMR capabilities of its Members; provide an architecture capable of expanding to meet the future LMR needs of its Members; develop funding mechanisms necessary to sustain the INSB JPA; and resolve technical and operational issues in the development and management of a wide-area interoperable government communications network; and

WHEREAS, the City of Redondo Beach, California, ("Redondo Beach") has agreed to take the initiative to interconnect their radio system with radio systems of other local cities through the future INSB JPA Prime Site to provide wide-area communications interoperability via the Interagency Communications Interoperability System Joint Powers Authority ("ICI JPA") Master Site to improve regional communications for public safety and general government resources;

NOW THEREFORE, BE IT RESOLVED BY THE GOVERNANCE BOARD OF THE INSB JPA:


SECTION 1. Redondo Beach is hereby admitted and approved to become a member of INSB JPA consistent with the terms, conditions, and obligations referenced within the Joint Exercise of Powers Agreement executed between the members of the INSB JPA.

SECTION 2. Redondo Beach shall agree to the payment of those Member Dues and Fees as set forth in the Agreement and INSB JPA Resolutions.

SECTION 3. The Chairperson of the Governance Board is hereby authorized to execute the Agreement with Redondo Beach on behalf of the INSB JPA to be effective September 1, 2016.

SECTION 4. The Secretary of the INSB JPA shall certify to the adoption of this Resolution.
